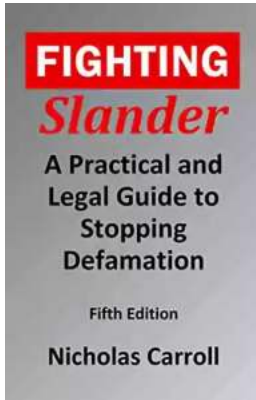

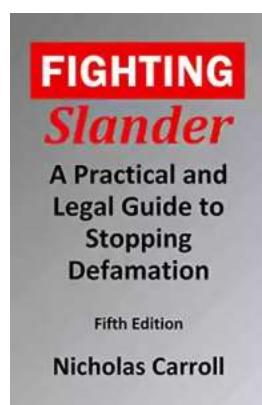

At 170 pages, Fighting Slander is thorough but digestible, in between the 10-page student guides meant to pass one exam and the 1,600 page practice guides that tell more than you want to know about defamation law.
