## The Gun-Free Killing Zones of America: A Sobering Look at the Consequences



In light of the evident shortcomings of gun-free zones, it becomes essential to explore alternative measures that can better protect individuals and communities from gun violence.


One approach could involve implementing stricter regulations on firearm purchases, focusing on comprehensive background checks and mental health
